Resolution. Whereas the Electors present at the annual township meeting held in the township of Bates on the 3<sup>d</sup> day of April A.D. 1895, did not determine the amount of poor tax to be assessed for the purpose of support of the poor, in said township as provided by law, therefore be it hereby Resolved that a poor tax of \$300.00 Three Hundred Dollars be assessed upon the taxable properties of the township of Bates for poor purposes during the ensuing year.
