A motion was made by Olof Anderson  
seconded by John Soderqvist that the Clerk be  
instructed to have the two Tickets nominated  
at the Two Caucuses printed the first Ticket  
was named the Republican Ticket the next  
was named the Taxpayers Ticket

It was moved by Olof Anderson seconded by  
Charles Otto that the Highway Commissioners  
Bond be fixed at One Thousand Dollars (\$1000)  
and the Township Treasurers Bond be fixed at  
Five Thousand (\$5000) for the next ensuing  
year ass. Forsberg, Otto, Anderson, Soderqvist.  
The Township Treasurer then presented his Books  
and Statements for settlement with the  
Township Board and the same were found  
to correspond with the Township Books  
and on motion made by John Soderqvist

seconded by ~~the Treasurer~~ Ole Anderson. The Treasurer's  
Statement was accepted by Forsberg, Otto, Anderson  
Soderqvist. says none carried.

A motion was made by Chas Otto that the  
amount of Eighty Five Dollars and Forty Five cents \$85.44,  
be placed <sup>belonging to Bridge fund</sup> to the credit of the Highway fund the  
motion was seconded by Olof Anderson and passed  
by the following vote says Forsberg, Otto, Anderson  
Soderqvist. says none carried.

The following Resolution was offered by Chas Otto  
Whereas it appears that John Celt were unjustly assessed  
on the S.W. of the S.E. 1/4 of sec 17. 43. 34. for the  
year of 1898. Be it Therefore hereby Resolved that we  
the Township Board allow him a Rebate  
of 58 cents on the contingent fund and 59 cts  
on the Highway fund and that the Clerk is here  
by instructed to draw orders for the amounts  
do It was moved by Ole Anderson seconded by  
Chas Otto that the foregoing resolution be  
adopted says Forsberg, Otto, Anderson  
Soderqvist. says none carried
