

Township of Bates March 27th 1900.

The annual Meeting of the Township board of the Township of Bates was held at the office of the Township Clerk in said Township on Tuesday the 27th day of March A. D. 1900.

The Meeting was called to order by the Chairman the Clerk called the roll and the following Members was present.

The minutes of last meeting was read and on motion duly carried approved as read. The board then proceeded to fix the Tp Clerks and the Tp. Treasurers bond. for the ensuing year. it was moved by Soderqvist. Seconded by Sjogvist that the Tp. Clerks. bond be fixed at the sum of \$100.00 and the Tp. Treasurers bond be fixed at the sum of \$5000.00 for the next ensuing year. which motion prevailed by all the members of the board.

It was further moved by Soderqvist. seconded by Sjogvist that the two Election ticket filed by the Clerk. be accepted and that Clerk be instructed to cause the same to be printed. which motion prevailed. The board then proceeded to settle up with the Township Treasurer and as the Treasurers books was corresponding with the Tp Clerks books it was moved by Forsberg. Seconded by Soderqvist that the settlement with the Township Treasurer be accepted.

The board then proceeded to make out a detailed Statement of all the orders issued and to whom issued and for what purpose the orders was issued. and the Clerk was instructed to cause said statement to be printed in not less than 5 and not

more than 50 copies, as required by act 262 of the laws of 1897.

The board then went into committee of the whole for the purpose of auditing and allowing the following bills brought before them for consideration and it was moved by Soderqvist supported by Sjogvist that the following bills be allowed and the chairman and clerk be instructed to draw orders for the same upon such funds of the township on which the same are allowed, which motion prevailed by all the members of the board, and the chairman and clerk proceeded to draw orders as follows:
