

Township of Bates November 13th 1900.

A Meeting of the Township board of the Township of Bates was held at the office of the Township Clerk on the 13th day of Nov A.D. 1900.

Meeting called to order by the Chairman Clerk called the roll and the following members was present.

Charles Olson Supervisor, Israel Carlson Clerk, Edward Sjogvist and Victor Benson Justice of the Peace

Minutes of last meeting was read and approved as read

The following resolution was offered by Carlson, and its adaptation was moved by Benson, and supported by

Sjogvist: Whereas it appears from the Township record of this Township of Bates, that at a meeting held by the Township board of said township on the 10th day of Feb. A.D. 1900. A Resolution was offered and adapted by the

said Township board, that the Supervisor was instructed and authorized to engage an attorney and commence proceeding against Mr John Alt. for a certain sum

of money paid by the County Treasurer out of a money belonging to this Township of Bates for the keeping of Mr John Alt's wife at the insane asylum at Newberg Mich. and whereas said Mr John Alt appeared before this board at a meeting held Nov 13th A.D. 1900. and testified that he is not in such a

circumstances that enables him to provide for and maintain his wife in the said insane asylum

and Mr John Alt. further testified that he is old and are crippled besides and if the township should take possession of the little property he may own should be ruin to him forever.

Therefore be it hereby resolved by us the Township board now assembled that we revoke the said resolution mention in the foregoing referring to the keeping of said Mr John Alt's wife at the insane asylum Newberg Mich. The roll was called on the above resolution Olson, yes. Sjogvist yes; Benson yes. Carlson yes; The votes being for the adoption of the resolution
