Bates April 7th 1906

The following are the minutes of a Troop meeting held at the Clerk's office on the 7th day of Jan 1906. Meeting called to order by the Chairman Clerk called the roll with the following members Present
 Charly Olson Supervisor Victor Benson Clerk
 Emil Soderqvist August Johnson Justice of the Peace
 Minutes of last meeting was read and approved. As August Johnson had been elected to the office of Justice of the Peace at the annual Troop Election held at School House No 2 on the 2d day of April 1906 and was said August Johnson had been elected to fill vacancy. Therefore it resolved that said August Johnson be allowed a seat on the Township Board of Bates. The roll was called on the above resolution and resulted as follows Charly Olson yes Victor Benson yes Emil Soderqvist yes resolution adopted.

The Board then proceeded to appoint our Health Officer for the ensuing year. and as it appeared to be two applicants for said office that being Louis Olson & Andrew Hanson then for the Chairman stated that a vote be taken on the above question. The Clerk then proceeded to prepare tickets for Ballot for voting and voting commenced and resulted as follows Louis Olson received 3 votes and Andrew Hanson received one vote therefore it was declared that Louis Olson was duly nominated and appointed Health Officer for the ensuing year.

The Board then went into committee of the whole for the purpose of auditing and allowing the following brought before the Board for consideration. It was moved by Soderqvist supported by Johnson that the following bills be allowed and Chairman & Clerk be instructed to draw orders upon the proper funds as follows
