Bates Township March 26th 1907

The following are the Minutes of a Township Board Meeting held at the Clerk's Office on the 26th Day of March A.D. 1907. Meeting Called to Order by Charly Olson. Clerk Called the roll with the following Members Present. Charly Olson. August Victor Benson. Clerk. Gothard Gordin. August Johnson. Justice of the Peace. Minutes of last Meeting was read and approved. Moved by Johnson seconded by Gordin that the Tax Clerk Bond be fixed at \$1000⁰⁰ for the ensuing year. and the Treasurer Bond be fixed at \$7500⁰⁰ for the ensuing year. Motion Prevailed by all Voting yea. Moved by Gordin seconded by Johnson that the 2 Election Tickets be approved and accepted. and Clerk be instructed to cause same to be printed Motion carried. The Board then Provided to settle up with the Township Treasurer as required by Law by Law. as the Treasurer Book was corresponding with the Clerk's Book as to all the receipts Orders Paid and money on hand. it was moved by Johnson seconded by Gordin. that the settlement with the Tax Treasurer be accepted Motion carried. The Board then Provided to make a full itemized statement of Orders Issued and Paid during the year and Clerk be instructed to cause same to be printed. Moved by Johnson seconded by Gordin that we the Township Board enter into a contract with the Indiana Road Machine Co for the Purchase of one Road Grader from said Company the above required Assent to and approved said Motion carried by all the members of the Board. said Board Grader to be Paid in yearly Payments to wit

\$ 100⁰⁰ Feb 15, 1908" 100⁰⁰ " " 1909" 60⁰⁰ " " 1910

at the rate of 6 percent per annum said Road Grader to be delivered at Iron River on or before the 15th day of May 1907

The Board then went into committee of the whole for the purpose of auditing and allowing the Bills brought before the meeting for construction Moved by Johnson supported by Nordin that the following bills be allowed and Chair and Clerk be instructed to Draw Orders upon the proper funds of the Township
