Moved by Krans seconded by Johnson that the bid of Nels Hallstrom for the construction of a stable at the townhall be rejected. motion carried. Moved by Krans seconded by Johnson that Frank Erickson and Adolf Forsberg be appointed to purchase building materials and to constitute a building committee for the stable building to be erected at the townhall.

Ayes Erickson, Krans, Johnson and Forsberg naves none. motion duly carried.

Moved by Krans seconded by Johnson that the Highway Commissioner be instructed to proceed to lay out and construct a highway from the S.W. corner of the S.E. 1/4 of the S.E. 1/4 Sec 5 in town 43 Range 34 and to be run on the section line east for a distance of about 170 rods ayes Erickson, Johnson, Krans and Forsberg naves none motion carried

Moved by Forsberg seconded by Krans that the rate of liquor bond be fixed at the sum of Six Thousand Dollars and that no less than two sureties be accepted. ayes Erickson, Johnson, Krans and Forsberg, naves none, motion carried

The board then proceeded to audit and allow the following bills and it was moved by Forsberg supported by Krans that the bills be allowed as read and that the Chairman and Clerk be instructed to draw orders for the same. ayes Erickson, Forsberg, Johnson and Krans. naves none.
