A meeting of the townboard of the township of Bates was held at the townhall in said township on the 16th day of July 1909.

The meeting was called to order by Frank Erickson supervisor. The roll was called and the following members were present Frank Erickson supervisor, August Krans and August Johnson Justices of the Peace and Adolf Forsberg township clerk. The minutes of last meeting were read and approved as read. Moved by Forsberg seconded by Krans that August Johnson be entitled to a seat on this board in power of his capacity as Justice of the Peace. motion carried. Moved by Krans seconded by Johnson that the bid of Nels Hallstrom for the construction of a stable at the townhall be rejected. motion carried. Moved by Krans seconded by Johnson that Frank Erickson and Adolf Forsberg be appointed to purchase building materials and to constitute a building committee for the stable building to be erected at the townhall.

Ayes Erickson, Krans, Johnson and Forsberg naves none. motion duly carried.

Moved by Krans seconded by Johnson that the Highway Commissioner be instructed to proceed to lay out and construct a highway from the S.W. corner of the S.E. 1/4 of the S.E. 1/4 Sec 5 in town 43 Range 34 and to be run on the section line east for a distance of about 170 rods ayes Erickson, Johnson, Krans and Forsberg naves none motion carried
