A meeting of the Township Board of the Township of Bates was held in the town Hall on the 28<sup>th</sup> day of March A. D. 1911 Ten o'clock a.m. the meeting was called to order by Victor Benson Supervisor. and the following members answered to there names as the roll was called Victor Benson Supervisor, August Johnson and Emil Soderquist Justice of the Peace and Charley Olson Clerk.

The minutes of the last meeting was read to the Board and upon motion being duly made and supported was ordered to stand as read.

The Board then took up the question of fixing the town Treasures Bond and the following resolution was offered Resolved that we the Township Board of the township of Bates do hereby fix the Bonds of the township.

Treasure at ten thousand Dollars. \$10,000 for the next year. Roll called on the above resolution Soderquist yes. Johnson yes. Olson yes. Benson yes. resolution carried. the Board then proceeded to settle with the township Treasurer and it was then found that the Book of the Treasurer was corresponding with the books Record and Accounts of the township Clerk the following resolution was offered by August Johnson who moved its adoption whereas we the Township Board of the township of Bates find the account of the Treasurer Olf Anderson with the statements of receipts and disbursements during the year and with the Clerks accounts therefore be it resolved that we the Township Board accept said statement in full settlement with said Township Treasurer this resolution was supported by Emil Soderquist Roll called Johnson yes. Soderquist yes. Olson yes. Benson yes. motion duly carried.

The Clerk then read the Bills to the Board and it was moved by Johnson to allow all the Bills except the Bill of the Munns. J. M. Co. as read this motion was supported by Emil Soderquist the roll was called on this motion and the members of the Board answered to their names as follows. Johnson yes. Soderquist yes. Olson yes. Benson yes.

On considering the Highway bill of the Munns J. M. Co. it was moved by Olson and supported by Emil Soderquist to allow the bill in question in full Roll called on motion and the members of the Board answered to their names as follows August Johnson No. Emil Soderquist yes. Charley Olson yes. Victor Benson yes thereupon the Chairman declared the motion duly carried.
