A meeting of the Township Board of the Township

 The minutes of the previous meeting was read by
 the clerk to the Board and upon a motion being
 duly made and supported was ordered to stand as
 read. A motion was made by Gordon and supported
 by Hedstrom whereas certain Brewing Companies who
 have paid only a warehouse tax on the business
 of selling malt brewed and fermented liquor, are in
 the habit of selling such malt brewed and fermented
 liquor at both wholesale and retail in this township
 and without paying any tax whatsoever therefor.
 Therefore it is hereby Resolved by this Board that
 the Clerk of this township be and is hereby authorized
 and directed to employ counsel to see such Brewing Co.
 are prosecuted for each and every violation of the
 laws of this State in regard to the sale and manu-
 facture of such liquor: and to see that the Pro-
 secuting attorney prosecutes such persons for said offense
 or see that another attorney be appointed by the people
 authorities to prosecute the same. Roll called to the above
