The question of ~~raising~~ <sup>increasing</sup> pay of Highway Commissioner from \$2.50 per day to \$3.00 per day came up before the board  
Vote taken on same by secret ballot was as follows Total Ballots cast 4  
For \$3.00 per day There was 3 Votes

Motion made by Hedstrom that the Overseer be raised from \$2.35 per day to \$2.50 per day  
motion seconded by Nordem  
motion carried unanimously.

Moved by Nordem and seconded by Hedstrom that the wages for Team hire be at the rate of \$5.00 per day  
motion carried unanimously

galvanized Iron Culverts. 75 ft. 12<sup>in</sup> 60 ft. 15<sup>in</sup>  
20 ft. 20<sup>in</sup>  
Motion carried unanimously

The following Resolution was offered  
by E. B. Hedstrom who moved its adoption

Be it resolved, that the H. W. Commissioner  
let contracts to do the repair work on the  
several roads of Bates Township,  
such as grading, cleaning ditches,  
graveling roads putting in culverts and  
cutting right of way also, such other work  
that the Commissioner may find profitable to  
be let

Be it further resolved, that the Commissioner  
confer with the Township board and call  
a meeting if necessary, for such purpose  
Be it further resolved that the High way  
Commissioner hereby agrees to work in  
conjunction and in a harmonious manner  
in all the details of such work
