

PROCEEDINGS OF TOWN BOARD MEETINGS

Meeting held on the 10th day of April A. D. 1917

A meeting of the Town Board of the Township of Bates was held in the town hall in the township on 10th day of April 1917. The meeting was called to order by Rudolf Forsberg Supervisor. The Clerk called the roll and the following members were present Rudolf Forsberg supervisor Jalmer Johnson Twp Clerk. Carl J Gustafson and Mike LeClair Justices of the Peace. It was moved by Gustafson supported by LeClair that the Bonds of the Township Clerk and the Highway commissioner be approved and placed on Record which said motion prevailed by all the members of the board. The board then proceeded to appoint a Health Officer for the ensuing year; and as Frank Erickson being the only applicant for the said Office, it was moved by Gustafson supported by LeClair that Frank Erickson be appointed Health Officer for the ensuing years motion duly carried by all the members of the board.

Then the board proceeded to fix the wages for hand and team labor on the highways for an indefinite time.

It was moved by Gustafson and supported by Johnson that the hand labor be paid at the rate of \$2.50 and the team labor at the rate of \$5.50 per day. Roll called on the above motion Forsberg yes. Johnson yes. Gustafson yes. LeClair yes. Anderson yes motion carried. The board then went into a Committee of the whole for the purpose of examining the bills brought before their consideration.

It was moved by LeClair supported by Gustafson that the chairman and the clerk be instructed to issue orders for the same upon such funds of the township upon which the same are allowed. Roll called. Forsberg yes Johnson yes Gustafson yes LeClair yes motion duly carried.
