## Record of Estrays.

A meeting of the township board of the Township of Bates was held at Forsberg's Hall, Mar. 19, 1918 at 9:00 o'clock A. M.

Meeting called to order by the supervisor with the following members present.  
Adolf Forsberg - Supervisor, Galmer Johnson - Clerk, Mike Le Clair and Emil Thunander - Justices of the Peace.

Minutes of the meetings held Mar 1, 1918 and Mar. 13, 1918 were read and approved.

The board then proceeded to settle with the township treasurer, Joseph Gendzwill; which work not being completed at 5:00 o'clock P. M.; the motion was made and duly supported that the board adjourn until the following morning, Mar 20, 1918 at 8:00 o'clock.

Meeting called to order by the supervisor, all members of the board being present.

The board then continued the work of settling with the township treasurer, Joseph Gendzwill, and it was found that the books of the township treasurer corresponded with the books, records and accounts of the township clerk, Galmer Johnson; whereupon the following resolution was offered by Thunander who moved its adoption:

Whereas, we, the township board of the township of Bates, find the accounts of the township treasurer, Joseph Gendzwill, correspond with the receipts and disbursements recorded by the township clerk, Galmer Johnson, therefore

Be it resolved; that we, the township board of the township of Bates accept said statement in full settlement with said township treasurer.

The above resolution was supported by Le Clair. Upon roll call, the vote stood as follows: -

Ayes - four, nays - none. Motion carried.
