It was moved by Carlson and seconded by Johnson that the township board meet twice a month during the summer. Vote on above motion, Yea Johnson, Carlson, Lindquist & Waite. Motion Carried.

It was moved by Carlson and seconded by Lindquist that the petition for the Hoimoshi & Shogunit extension road be laid on the table. Vote on above motion, Yea Carlson, Lindquist, Johnson & Waite. Motion Carried.

Moved by Waite and seconded by Johnson that the Reiman road be put under construction. Vote on above motion Yea. Carlson, Johnson, Lindquist, & Waite. Motion Carried.

Moved by Waite seconded by Johnson that the bills for the following be approved as read and the Clerk & Chairman be ordered to draw orders for the same. Vote on above motion, Yea, Carlson, Johnson, Lindquist & Waite. Motion Carried.

The following resolution was offered by Lindquist who moved to adoption:—

Whereas it appears that the Road Repair Fund of the Township of Bateer chon Co., Michigan is exhausted, no money remaining therein, and whereas it appears that the Highway Improvement Fund of said Township is likewise exhausted no money remaining therein, and whereas a condition exists with reference to said funds which makes it

imperative and necessary, that the said township borrow money for said funds, in Anticipation of the Collection of taxes for the Current year in order that the work of said Township in Road repair and Highway improvement may be Carried on.

Therefore be it resolved, that the Township of Bates will borrow from one or Anyone or more of the Banks of the County of Lyon, sums of money for said two funds up to the Maximum Amount allowed by law at a lawful rate of interest.

Be it further resolved, that the Supervisor and Clerk of said township be and they are hereby appointed a Committee to negotiate and complete said loans consistent with the terms hereof.

Be it further resolved, that said Supervisor and Clerk be and they are hereby Authorized and empowered by this Board, for and in behalf of said Township to make, execute, and deliver to said Bank or Banks the necessary and proper evidences of debt covering said loans.

Which resolution was seconded by E. Johnson and passed by the following vote. Yeas. E. Johnson Carlson, Lindquist and Waite. Nays None.
