

Minutes of the meeting of the Bates township Board held in the Bates Town Hall, May 16, 1925.

Members present were Ben Mitchell, Carl Lindquist, Alvin Hanson, Otto Trybom. Motion made by Mitchell supp by Hanson that the truck driver and Roller man be paid \$4.50 a day on the Bates Township Roads. Yes Lindquist, Hanson, Mitchell and Trybom. Nays none, motion carried.

The following resolutions were offered by Mitchell who moved its adoption.

Whereas it appears that the Road Repair fund of the township of Bates, Iron Co. Mich. is exhausted no money remaining therein and whereas it appears that the Highway Improvement Fund is likewise exhausted no money remaining therein and whereas a condition exists with reference to said funds which make it imperative and necessary that the said township borrow money for said funds in anticipation of the collection of taxes for the current year in order that the work of said twp in Road Repair and Highway Improvement Funds may be continued.

Therefore be it resolved that the twp of Bates will borrow sums of money for said two funds up to the maximum amount allowed by law at a lawful rate of interest.

Be it further resolved that the Supervisor and Clerk of said twp be and they are hereby appointed a committee to negotiate and complete said loans consistent with the terms hereof.

Be it further resolved that the said Supervisor and Clerk be and they are hereby empowered, appointed and empowered by this Bd for and in behalf of said township, to make execute and deliver to the person or persons, firm or firm corporation or corporations Banking or otherwise the necessary and proper evidence of debts covering said loans, which resolutions were supported by Trybom and passed by the following votes:
